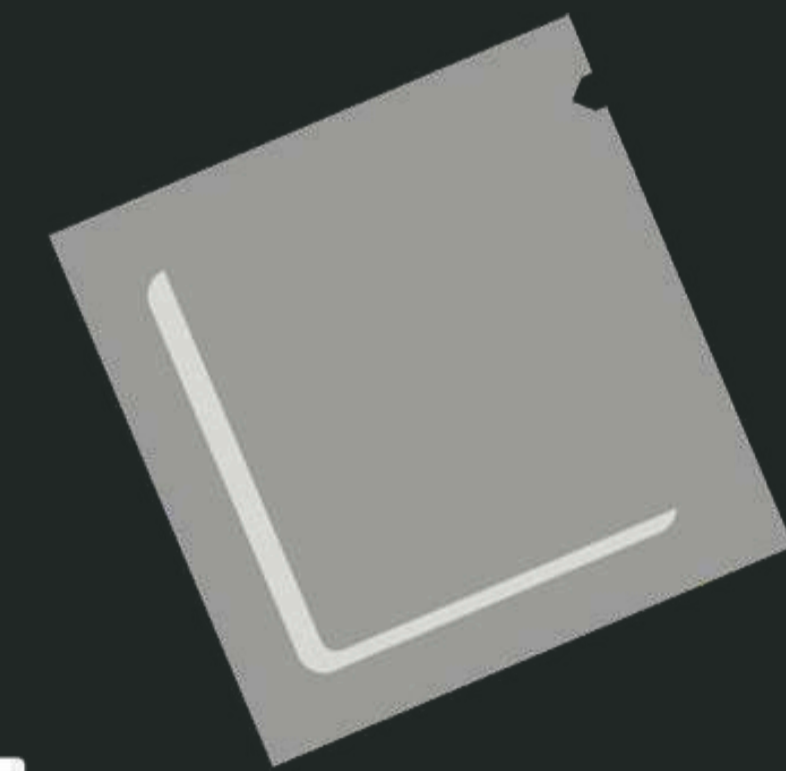

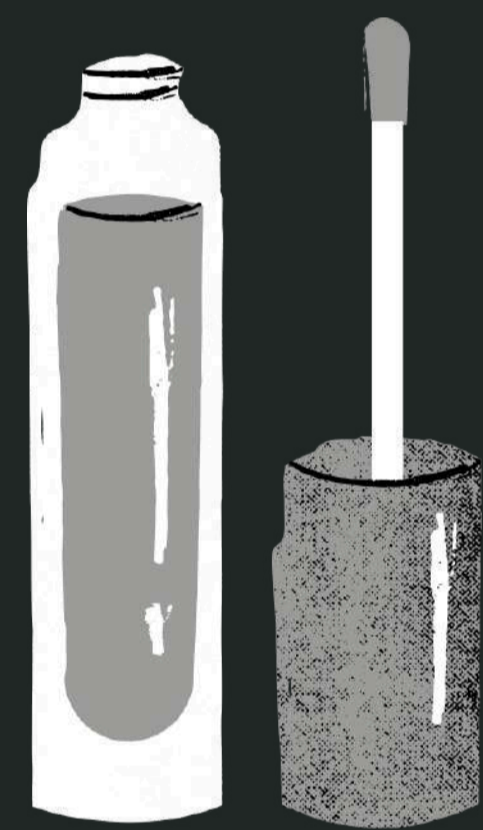

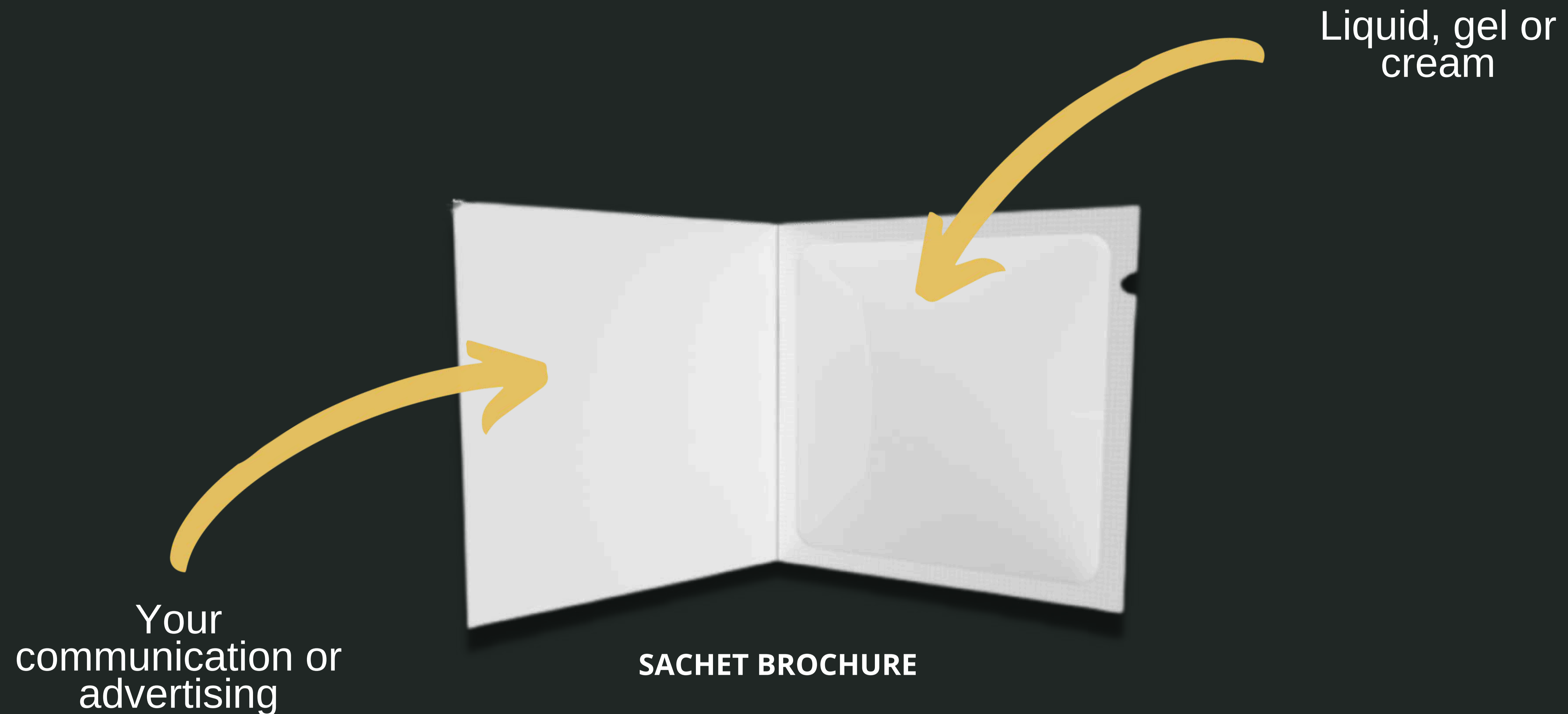
The single-dose sachet is **our specialty**. It is a type of container that allows you to bring the product to the consumer as a free sample or as a sales container.

We take care of the development and comprehensive packaging of any project aimed at single-use packaging.

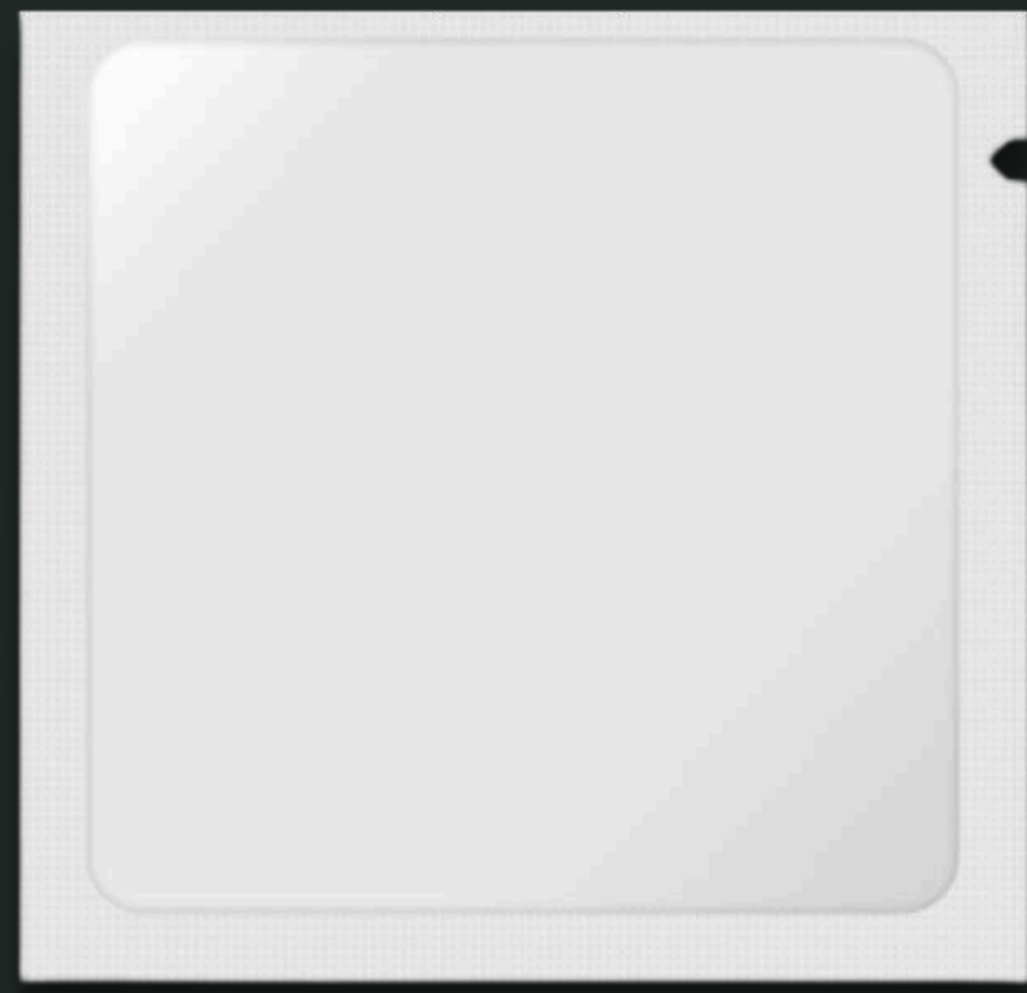

## PHASE 0

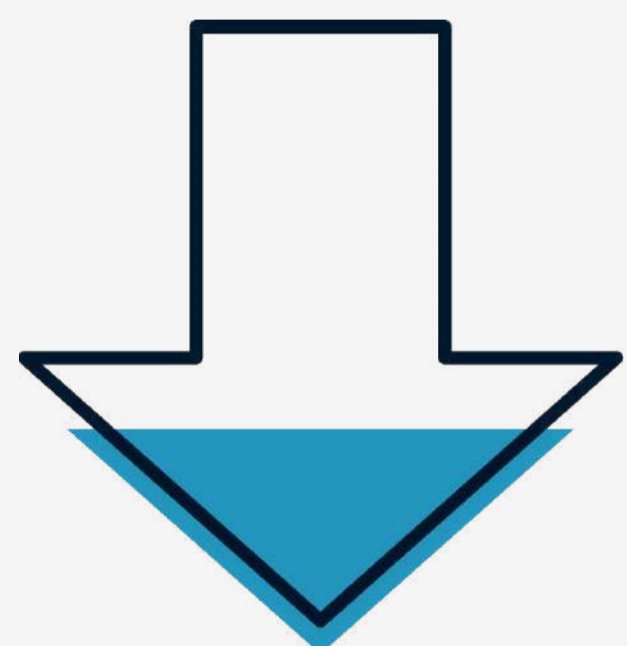
The process begins when a client shares their project with us, and together with the Commercial department we make sure to advise them on the best single-dose format.

## PHASE 1

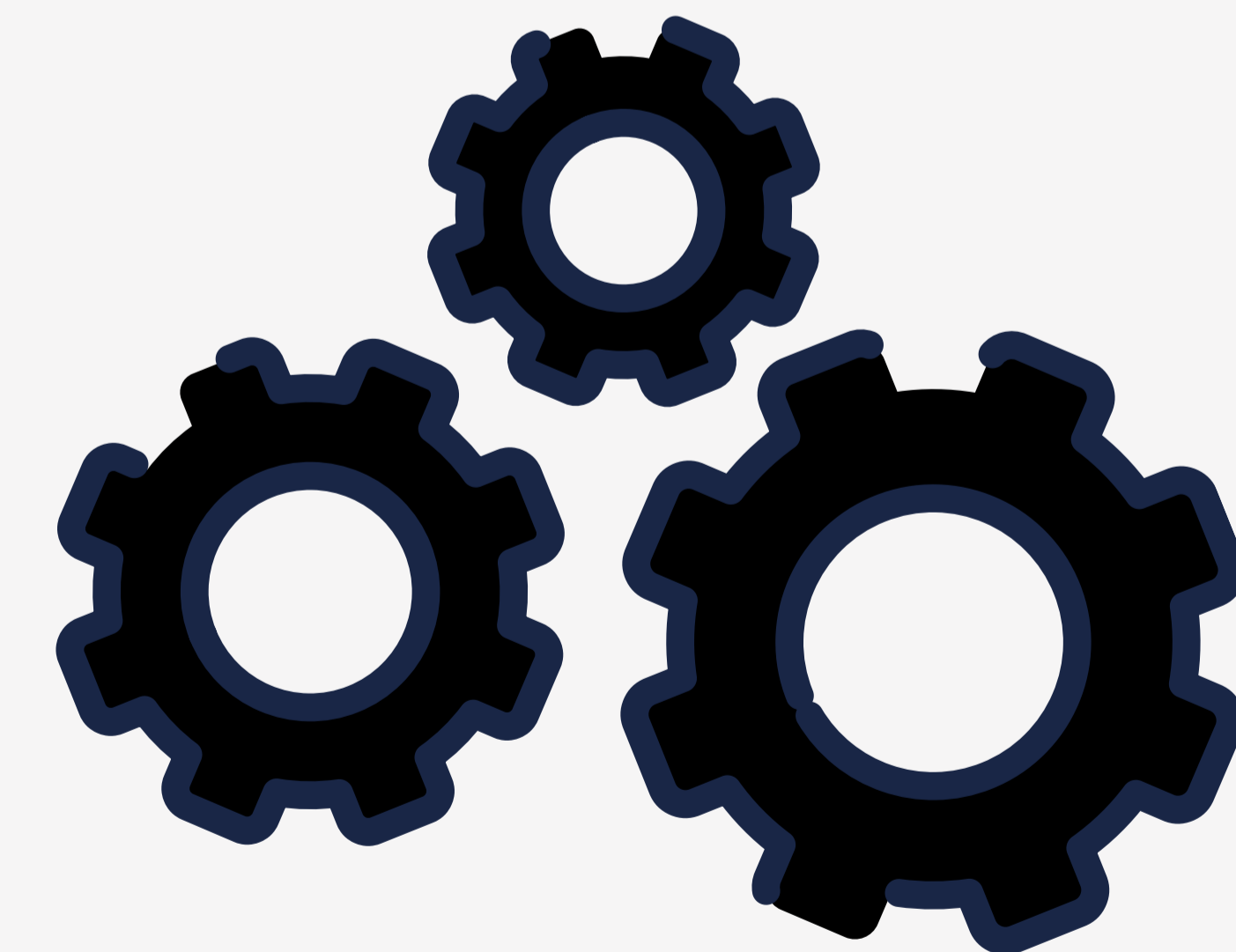
